Our vision is to give young people and the opportunity to reach their potential through sports, coaching and mentoring by demonstrating the love of Jesus.

We have supported local young people/children in 2021 – April 2022 reaching over 150 young people and children through after school activities, Saturday morning football sessions, Mentoring sessions, Self esteem sessions, & Boxercise Online & Physical

Young Person B "Without the football on a Saturday morning I would have maybe got in a bit of trouble"

Parent "This Charity has supported my Daughter during school, The anxiety course has helped her become more confident and she no longer becomes anxious at attending school

Effects we have had.

When C started playing football, he would be quite aggressive and storm off the pitch if the team lost. He would not really engage with his team and was often excluded from school activities. The charity quickly established a rapport on C and worked on his anger, encouraging him to play as a team member. Mark McGowan worked once a week with him and at training and he gradually started to become more involved and less angry. C is now a full member of the football team and is now club Captain.

Activities

One to one sessions, Friendship clubs and Self esteem, Anxiety Management programmes.

It has purchased some useful material to add this delivery and the secondary school students really enjoy the weekly sessions.

The charity has 2 football teams an under 13 (14 players) and a under 16 (15 players). The teams train once weekly and play every Saturday throughout the season (September – May). The teams have various abilities that play in the teams. We have boys that have anger issues, ADHD, and learning disabilities. We work alongside the parents and player to support and encourage them.

The Charity also delivered a weekly Boxercise session at a local school from September - November 2022.

When planning our activities and projects for the year the trustees and Director have considered the commission's guidance on the young people's benefit and in particular, the specific guidance on charities that work in religion, children, and young people.

To continue the work, it is important we continue to work alongside the local schools, Hampshire Football Association and the National Football Association as well as safeguarding agencies, and the local county FA.

Achievements & Performance

Shoot Academy are keen to offer a range of services during the week and weekends over the course of the year that our community find both beneficial and fulfilling.

Our boxercise sessions started in Person in October 2022 reaching 10 students on a weekly basis. This is continuing into 2022

The charity also introduced a Anxiety Management and one to one sessions to a local school reaching 12 year students each week.

Mission and Evangelism

Giving young people/ children the opportunity to develop emotionally, mentally, and physically through sharing our faith has been incredibly well received.

Our newsletter is sent out to over 100 subscribers every quarter. The newsletter keeps our parents, schools, churches, and the wider community informed of the important matters and developments as well as the good news affecting the charity.

Being able to have the use of facilities has seen the charity continue to deliver the project it is delivering. We continue to have some strong support by some churches in the community offering various ways of support.
